1. Application Forms will be accepted till 3.00 pm on 05 /11/2024.
2. The agency shall submit the Demand Draft drawn in the favour of "Entertainment Society of Goa" along with the application.
3. The EOI/Proposal shall be submitted in a sealed envelope super subscribed as "Expression of Interest/ proposal for Setting up of stalls for 55<sup>th</sup> IFFI 2024".
4. The vendor will be provided with a stall of size 10ft x 10ft at Inox Courtyard / promenade
5. The submission of bid, above or equal to the minimum reserved price doesn't guarantee the allotment of stall.
6. Use of gas cylinders on any stalls is strictly prohibited. However electrical appliances such as oven, induction, hot plate, etc. can be used for cooking
7. FDA/any other necessary license should be taken care by the agency.
8. The stall/ stall space will be allotted based on first come first serve basis by ESG.
9. Garbage should be managed by the agency / stall owner.
10. Only one stall will be allotted per application.
11. No sponsorship should be raised by the agency / stall owner.
12. Dishes / beverages to be served in disposable or eco friendly products.
13. Incomplete Applications are liable for rejection.
14. For any dispute, ESG shall be the final authority and its decision shall be final and binding. ESG reserves all rights to accept or reject or cancel any or all EOI/proposals in part or full without assigning any reason thereof.
15. Once confirmation of allotment of space along with 100% advance payment is done, no request of refund of amount will be entertained after 07/11/2024.
